- A contributor of treasure, beyond tuition, to the parish according to the means of the family

Payment Information

- Tuition, and Extended Care are approved by the parish Finance Council after careful analysis, dialogue, and review and in collaboration with school administration.
- These rates apply to active, participating, contributing members of St. Patrick Parish. Non-active, non-participating, non-contributing families will be charged the non-parishioner rates.
- The multi-student discount applies to Grades K-8 only. Our Preschool Program is self-funding.
- Option 1 is a single payment made by cash or check on or before July 1st. (Full amount less the pre-paid registration fee.)
- Option 2 is a twice yearly payment made by automatic withdrawal July 1st and the following January 1st. (One-half tuition amount less pre-paid registration fee).
- Options 3 and 4 are monthly plans processed through FACTS on the 10th or the 20th of the month as an automatic withdrawal from your checking or savings account. The necessary documentation has been included in your registration packet.

Registration Fee

- A \$100 non-refundable registration fee is required at the time of registration at the parish business office.
- This fee is **per student.**
- This fee is applied to the total tuition bill.
