Payment Information

- Tuition, Extended Care, and Bus rates approved by the parish Finance Council after careful analysis, dialogue, and review and in collaboration with school administration. The Technology fee of \$150 per family will remain the same as 2023-2024. This fee meets a direct student benefit and classroom need and will help meet current software requirements required to operate the programs used in the curriculum as well as savings future upgrades. It is important for us to keep tuition and other school programs affordable while continuing to provide and enhance our outstanding Catholic education, curriculum, and programs.
- These rates apply to active, participating, contributing members of St. Patrick Parish. Non-active, non-participating, non-contributing families will be charged the non-parishioner rates.
- The multi-student discount applies to Grades K-8 only. Our Preschool Program is self-funding.
- Option 1 is a single payment made by cash /check or through FACTS on or before July 1st. (Full amount less the pre-paid registration fee.)
- Option 2 is a twice-yearly payment made by automatic withdrawal July 1st and the following January 1st. (One-half tuition amount less pre-paid registration fee).
- Options 3 and 4 are monthly plans processed through FACTS on the 10th or the 20th of the month as an automatic withdrawal from your checking or savings account. The necessary documentation has been included in your registration packet.
- A \$125 late fee will be assessed for any payment received after the due date.

Registration Fee

- A \$100 <u>non-refundable</u> registration fee is required at the time of registration at the school office or through FACTS.
- This fee is per student.
- This registration fee is applied to the total tuition bill.
- A late registration fee of \$125 per student will be charged if enrollment is not completed within the two week period of open enrollment. This \$125 fee is not refunded and is in addition to tuition.
- The Technology fee is applied to the total tuition bill and is \$150 per family.
- Re-enrollment registration period will be February 1-February 16.
